1996 – Began downloading publications off the Internet

2000– Scanning and Digital Archive funded (DMDS) \$1 million

2001 – Electronic Records Archivist and consultant hired

2003 – Began archiving Governor's website (recreated Governor's 1997 website)

2006 – e-Archives is available to the public on the Internet

2008- Began evaluation of **DSpace**

2009 – e-Archives relaunched with **DSpace**

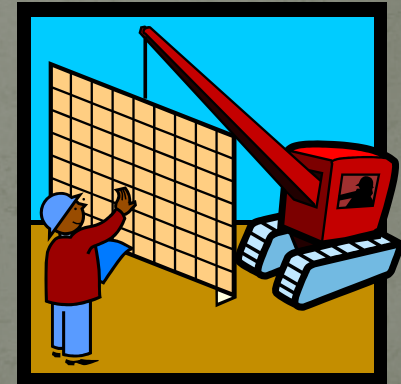
2010 – Began evaluation of **Archive-It** – Became full member in 2012

Electronic Records Working Group (ERWG)

- Formed 2002
- Representatives from KDLA, COT, and the Offices of the Attorney General ; Courts, Legislature, local agencies, universities, and Auditor of Public Accounts
- Develops suggested policies, guidelines, and recommendations for addressing electronic records issues.

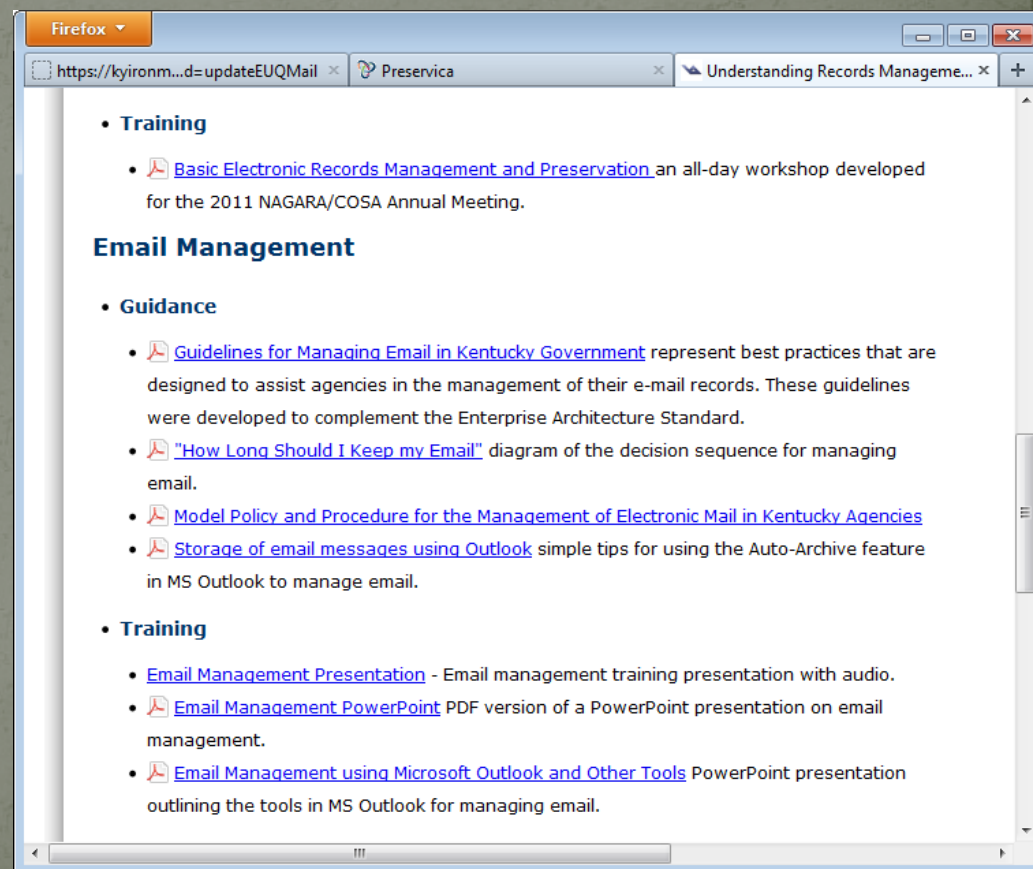

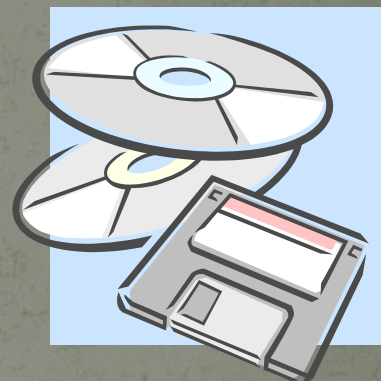

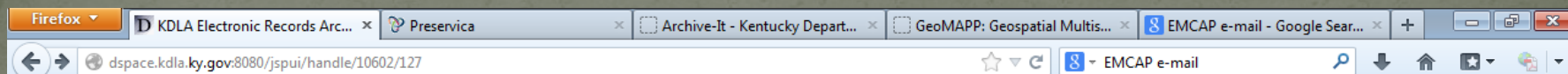

In 1956, the Department of Economic Development was created as the successor to the Agricultural and Industrial Development Board, which was created in 1948. In 1962, the Department was renamed the Department of Commerce. The Department was placed under the newly created Development Cabinet by Executive Order 72-1167, issued on December 22, 1972. Also included within the Cabinet were the Departments of Agriculture, Fish and Wildlife, and Parks, as well as the State Fair Board and the Bicentennial Commission.

In 1982, the Development Cabinet became the Commerce Cabinet, which was renamed in 1988 as the Cabinet for Economic Development. The Cabinet formerly included the Department of the Arts, the Tobacco Research Board, and the Kentucky Geological Survey. An Executive Order transferred the Tobacco Research Board and the Kentucky Geological Survey to the University of Kentucky. The Department of the Arts was abolished by Executive Order 90-727, which was issued on August 7, 1990. Its divisions were transferred to other areas of state government. In 1992, the Kentucky Economic Development Partnership was created as a board to govern the Cabinet, and the Kentucky Economic Development Finance Authority replaced the Kentucky Development Finance Authority and the Kentucky Rural Economic Development Authority.

The Cabinet for Economic Development is the primary state agency in Kentucky responsible for creating new jobs and investment in the state. Programs administered by the Cabinet are designed to support and promote economic development within the state, primarily by attracting new industries to the state, assisting in the development of existing industries, and assisting communities in preparing for economic development opportunities. Currently, the Cabinet consists of the Office of the Secretary, the Department for Business Development, the Department of Financial Incentives and the Department of Commercialization and Innovation.

Cons:

- Cost = IT support
- Open source – IT support
- Out-of-the-box product not easy to modify
- Mass Import hard
- Compound Objects
- Lack of “Robust” preservation tools*

2011 – “The Audit”

- Summer 2011 Participated in the PTAB audit
 - Primary Trustworthy Digital Repository Authorization Body
- 6 Test audits
 - 3 in US & 3 in Europe
 - KY only government archives
- Centered around:
 - **ISO 16363** – Requirements for Audit and Certification of Trustworthy Digital Repositories
 - **ISO 16919** – Requirements for bodies providing audit and certification of Trustworthy Digital Repositories

Audit Findings

- METRIC 3.1.2 – The repository shall have a preservation strategic plan that defines the approach the repository will take in the long-term support of its mission.
 - Move to a “Financially Sustainable” program; ID all the designated communities and adopt a strategic plan
- METRIC 4.3.1 – The Repository shall have documented **preservation strategies** relevant to its holdings.
 - System for validating the integrity of the defined AIP and normalizing/migrating it
- METRIC 5.2.1 – The Repository shall maintain a systematic analysis of the **security risk factors** associated with data, systems, personnel, and physical plant.
 - Multiple-geographically dispersed copies of AIP

Next Steps

- “Financially Sustainable” program
 - “Line item” funding better than “Ad-hoc” funding
 - Government archives serve at the whim of the government
- Strategic planning underway
 - All policies and procedures
 - Identifying operational and developmental systems
 - Watching out for the buses
- Designated Communities – Everyone

Preservation Business Challenges

- **Automate** largely distributed process of ingest and preservation to lessen cost of labor and be more efficient
- **Import** effectively from our access system
- Establish **connections** from our network to preservation system and back again
- Gain **intellectual and physical control** over growing number of electronic records
- Manage the holdings through **time**



Selection Process



- **Demonstrations** of the product
 - Stand-alone product – Safety Deposit Box (SDB)
 - Examined **studies** by state archives
- Established a list of **functional requirements**
- Began a pilot with a cloud-based solution
 - **6 weeks test** of developing Preservica product spring of 2012
- Negotiated a **contract** for the service
- **Purchased Preservica** in November 2012

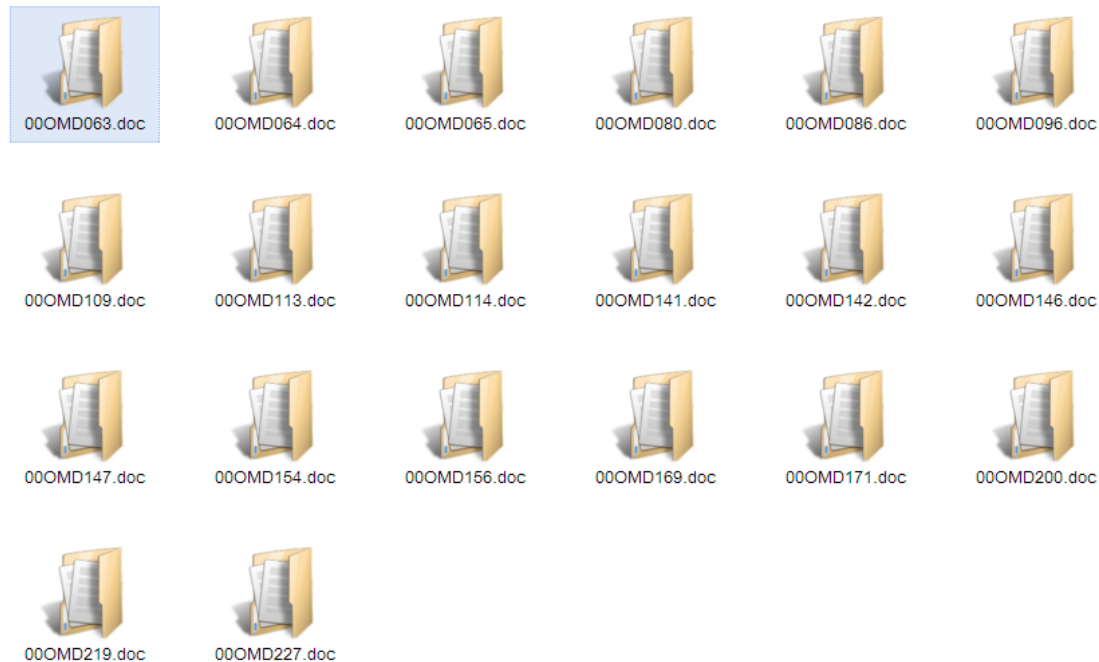

Preservica Issues (so far)

- Problems with the “Pipe”
 - File Size upload issues
- Currently have about 0.25 TB in Preservica
 - 135,820 files, for a total 262 GB loaded in a year
 - Focusing on records not in DSpace
- Working through metadata issues
 - XIP – METS – DC – It’s all XML, right?
- Integration with Dspace
 - More metadata issues: Qualified DC vs Basic DC
- Not really designed for public access, but re-designing it this year
 - KDLA still relying on DSpace for access



Thoughts about the “cloud”

- Cost – Cheaper than stand-alone system
- Full range of services and support
 - Use of templates to automate descriptive and accession metadata insertion
 - Automated technical data extraction from files
 - Format normalization and migration
- Administrative control of the archive through service
- Geographic dispersal of copies
 - KDLA Goal – Local copies of AIP
- Little or no on-site maintenance
